- Approval of previous Meeting Minutes by attending Board Members
- **President's Report** – John Monser
  - John thanked previous Board Members for their service to the Community. (Charley Freeman, Ken LaMarca, Donna Walston)
  - Thanks to team members for making Covid Vaccines a success for our Community and referenced the difficulties we have all faced this year with the closing of various activities but that expectations are high for the rest of this year

- Reminder of Speed Limits throughout our property and the need for caution
- Security Camera has been replaced and new monitor is needed so all cameras can be reviewed
- Request that along with seeking out Board Members that Residents also drop questions in the drop box at the Clubhouse. Especially those that would require the Board to research information

- **Ameritech Management Report** (Dave Fedash)

Inspections are back to normal standards with 11 for the Month of March and a Compliance Committee Meeting also completed for March

- **Treasurer Report** (John Monser)

We have influx of cash representing dues being paid for the entire year by some Residents. This will even out as year progresses

- **Committee/Club Reports**

- Architectural Committee (Carl Lafrance) Carl noted that Residents need to keep in mind the requirement to obtain permission prior to actually doing work on their homes. Ongoing issue. Rules and Regulations have been updated and Residents need to follow. Addressing earlier comment with regards to colors for homes in Community, Carl reiterated approvals and required from both Architectural Committee AND the Board and this process is being followed
- Social Club (Dale Mathurin) Dale addressed concerns with regards to events still closed for our Residents and expressed hope that all activities will soon be able to resume. - **Unfinished Business** (Sal Chieffo)
  - Clubhouse floor replacement. Sal stated that the floor company will honor bid from last year and will meet with the Board to answer any additional questions. Board will then review and take vote to determine proceeding with work.
  
- **New Business** (John Monser)
  - Need for new Monitor for Security Cameras. Security group suggested expensive system. Board approved purchase of a standard monitor that will work with our system.
  
  - Pool Chair Repair – Based on comments provided earlier Board approved working with warranty and moving forward to obtain repairs/replacements as appropriate.
  
  - Pool New Hire – Based on comments that Chuck may be retiring soon there is a need to work now to establish a replacement. John Monser will lead search for appropriate contractor to step into vacant role upon need.
